### **Decision details**

Mrs Mohamed Seth practising certificate for 2024 / 2025 is subject to the following condition/s:

- 1. Mrs Mohamed Seth shall not practise as a sole practitioner or sole manager or sole owner of an authorised recognised body.
- 2. Mrs Mohamed Seth is not a compliance officer for legal practice (COLP) or a compliance officer for finance and administration (COFA) of an authorised body.
- 3. Mrs Mohamed Seth shall not provide reserved or unreserved legal services on her own account under regulations 10.2(a) or (b) of the SRA Authorisation of Individuals Regulations.

In these conditions the terms are as defined in the SRA Glossary.

#### Reasons/basis

The above conditions are necessary in the public interest. They are reasonable and proportionate having regard to the purposes set out in



regulation 7 of the SRA Authorisation of Individuals Regulations, and the regulatory objectives and principles governing regulatory activities as contained in section 28 of the Legal Services Act 2007.

#### **Outcome of SDT Hearing**

This notification relates to a Decision to prosecute before the Solicitors Disciplinary Tribunal. This is an independent Tribunal which reaches its own decision after considering all the evidence, including any evidence put forward by the Respondent. The Tribunal had certified that there was a case to answer.

The matter was heard on 15 October 2024.

The Tribunal ordered that Samira Mohamed Seth:

Pay a fine of £7,000 and be subject to conditions imposed indefinitely by the Tribunal, that she may not:

- 1. Practise as a sole practitioner or sole manager or sole owner of an authorised or recognised body;
- 2. Be a Compliance Officer for Legal Practice or a Compliance Officer for Finance and Administration
